

# Leland Landers

Leland Landers was a lifetime resident of Wyoming and a 66-year resident of Gillette. His life included serving in the Army and receiving a BS/MS from the University of Wyoming in Agriculture and Science.

Thirty-seven years as the Superintendent of the University of Wyoming Experimental Farm in Gillette allowed Leland to plant hundreds of trees that we all enjoy today at the Cam-Plex Park as well as experiment with grasses and crops that were best suited for the NE Wyoming climate. These interests were complimented with his love of wildlife, geology, formation of the land, traveling, fine arts, and rodeos. He became a pilot, was the oldest member of the Gillette Lion's Club, and received the John Campanius Holm award for his accomplishments in the field of meteorological observations.
